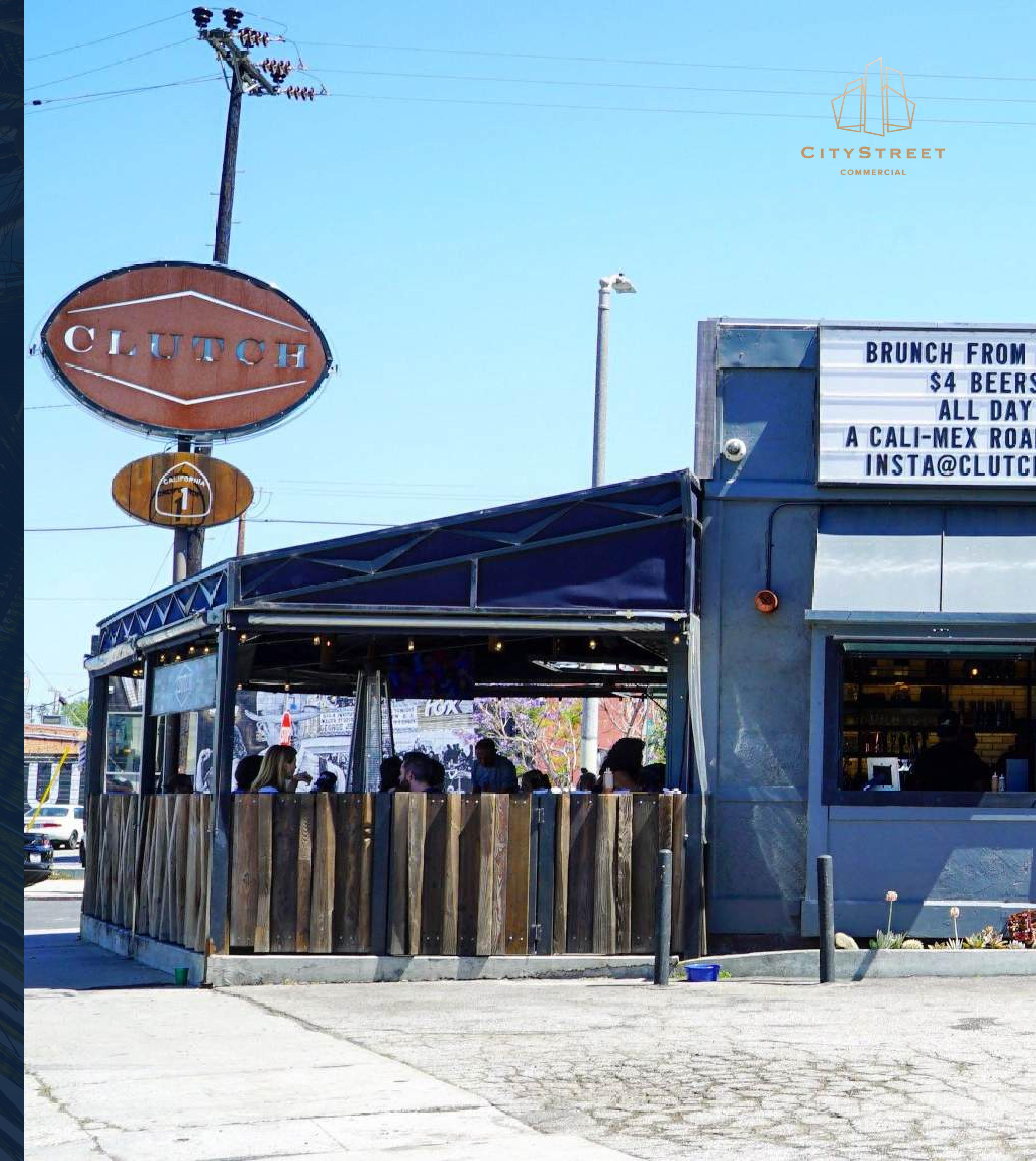
Area Highlights

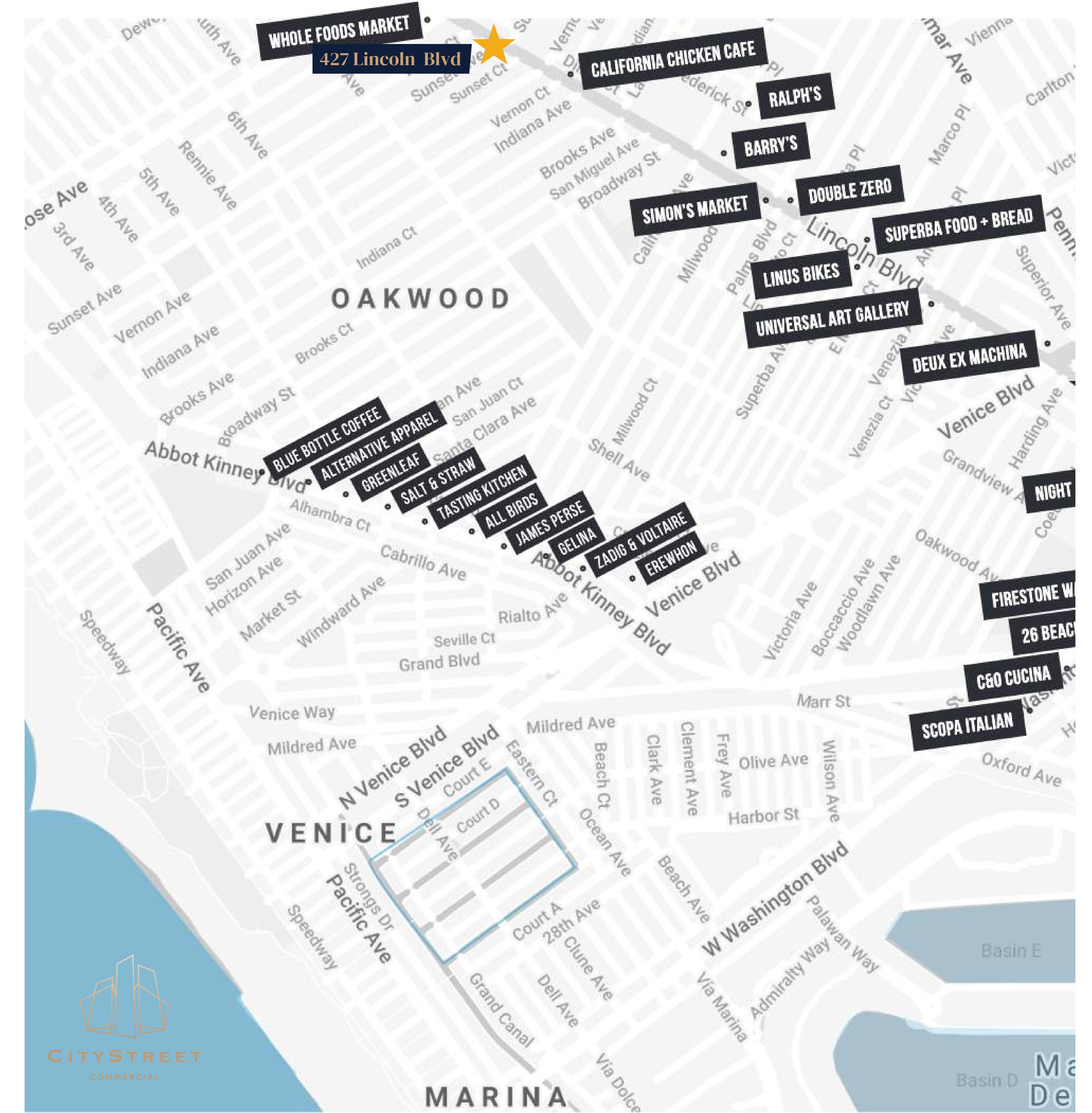

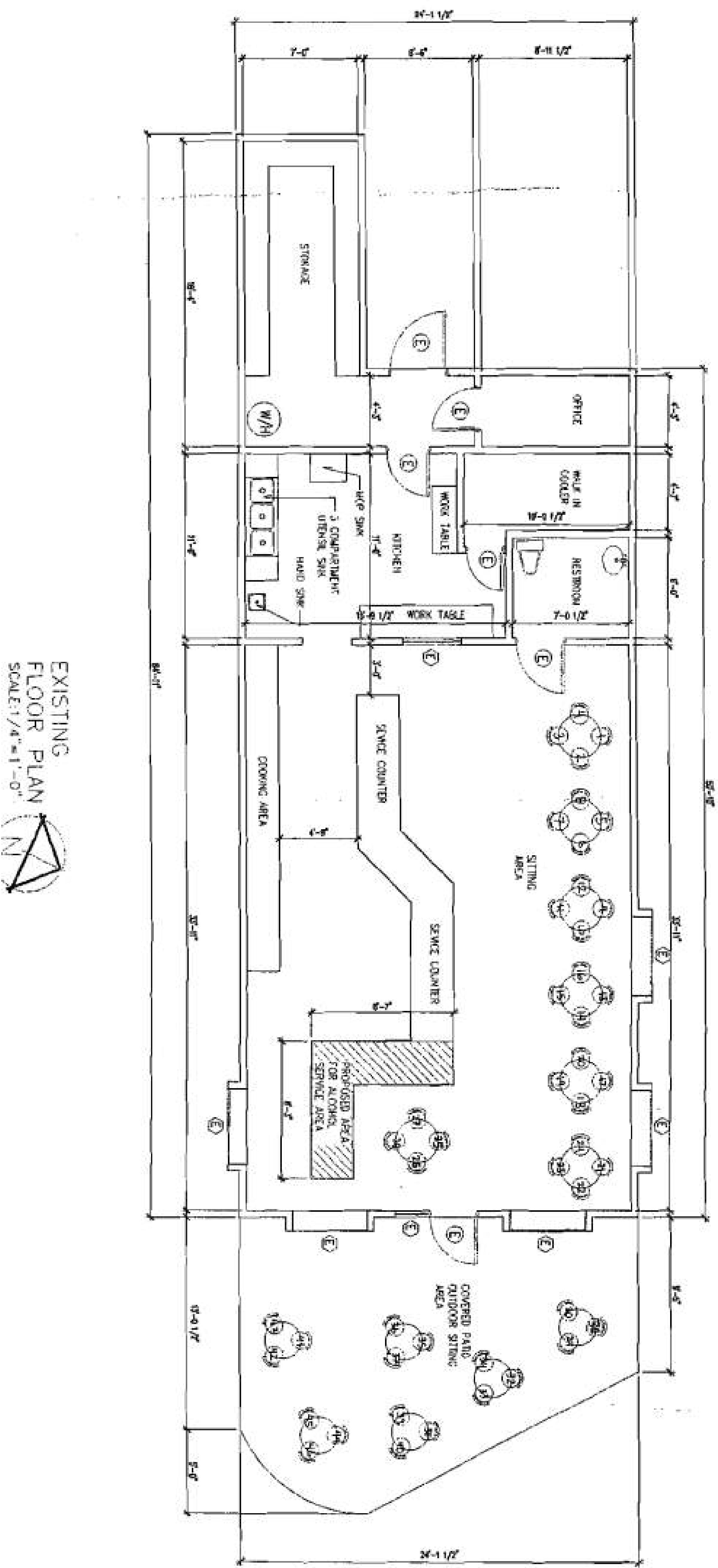

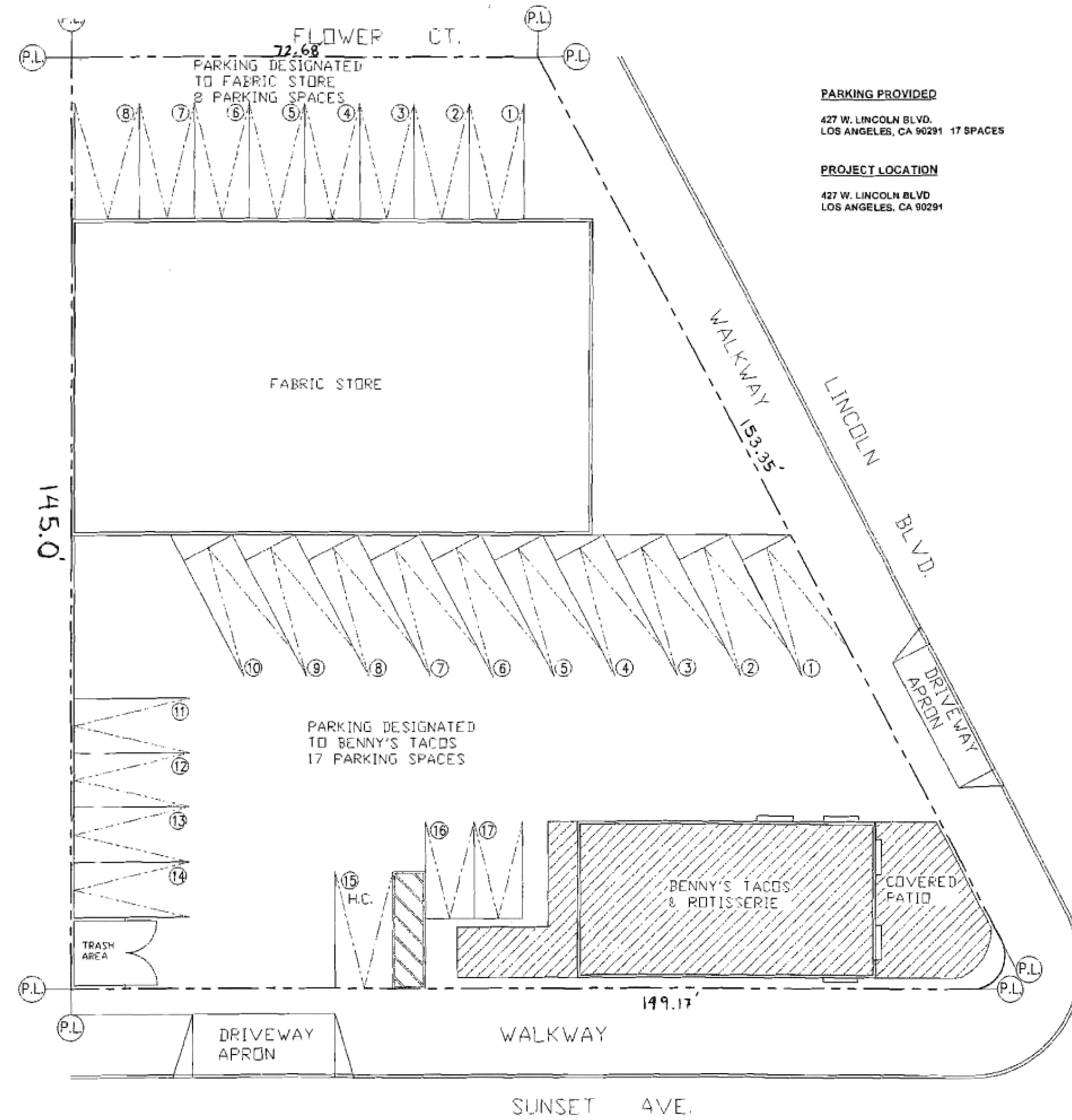
